# DesignUp Conference 2022 | TERMS OF USE

These terms and conditions (**Terms**) govern your purchase of the tickets for (**Tickets**), and attendance of DesignUp 2022 conference proposed to be conducted by DesignUp Conf LLP (**DesignUp**), a limited liability partnership having its registered office at 4<sup>th</sup> Floor, Salarpuria Tower 1,

Before proceeding, please read these Terms carefully and click on the "Accept" button provided [below] *OR* [in the pop-up dialog box]. If you do not agree to these Terms, you will not be able to access or use the website and purchase Tickets. By clicking "Accept", you signify your acceptance of these Terms (as amended from time to time), and agree to be bound by them. IF YOU DO NOT AGREE TO THESE TERMS OF USE, PLEASE CLICK ON THE "EXIT" BUTTON AND YOU WILL BE REDIRECTED AWAY FROM THE WEBSITE.

These Terms may be amended by DesignUp from time to time. You are advised to periodically review the Terms on the website from time to time such that you are aware of the amendments, if any. The terms "user", "you" hereunder refer to the person visiting, purchasing Tickets, accessing, browsing through and/or using the website at any point in time. The terms "we", "us", "our" refer to DesignUp. Should you have any clarifications regarding the Terms, please contact us at team@designup.io.

Tickets may only be purchased by persons who can form legally binding contracts under the Indian Contract Act, 1872. Any purchase of Tickets is subject to availability and you making full payment. Tickets purchased are non-refundable. You may transfer your Ticket to another person however DesignUp must be informed of such transfer atleast 1 week prior to the Conference via email to <a href="team@designup.io">team@designup.io</a>. This email should specify details of the person to whom the Ticket has been transferred to, including their contact details. Delegate passes issued for use at the Conference are valid for the named attendee only and you may be asked for photographic ID during the Conference. If you are unable to provide identification which matches your delegate pass, you may be asked to leave the Conference.

### 2. Conference
